Course Description

Every day, students are teased, intimidated, harassed, and hurt by other students. Bullying is a big problem in our schools and educators can do something about it. This course will help all educators and staff members to create a classroom/school environment where everyone feels safe, accepted and valued. It will help you to identify and empower victims of bullying as well as act quickly and effectively when learning of a bullying incident. Participants will also learn how to effectively communicate with parents while establishing a zero-tolerance policy for bullying. This course is a must for all educators K-12.

Course Description

Know

1. the difference between the facts and myths of bullying.
2. district and/or building policies against bullying.
3. cyberbullying and its harmful effects.

Understand

1. how they can help prevent bullying in their classes and schools.
2. that bullying manifests itself in many different kinds of behaviors, some of which are more easily noticed than others.
3. myths and misconceptions about bullying, bullies and the bullied.

and Be Able To

1. establish classroom rules and consequences that promote zero-tolerance for bullying.
2. identify and diffuse a bullying situation.
3. communicate effectively with parents of both bullies and victims.

Methods of Instruction

Teachers enrolled in this course will evaluate primary and secondary sources in order to be able to effectively communicate with parents while establishing a zero-tolerance policy for bullying. They will communicate with other teachers around the state and country to share success stories and gain insights into best practices in instruction. They will complete assignments that assess their understanding of bullying prevention and be challenged to apply their learning immediately to their own classrooms, schools, districts and communities.

Students will connect with each other throughout the course within forums and various other types of online feedback options built into each class.

Methods of Assessment

In order to earn an A in class, a student must complete all of the assigned readings and assignments, participate in all discussion forums, and compete all of the practicum tasks. This includes but is not limited to analyzing a bullying scenario and discuss how they would handle the situation, how they would guide the bully and victim and their families and include a classroom lesson on bullying prevention.

In order to earn a B in class, a student must complete all of the assigned readings and assignments, participate in all discussion forums, and analyze bullying scenario, no lesson plan.

Instructors are online each day of the course and correspond with students through the course itself, feedback on assignments, e-mail, and by phone.
